# **Sporting Chance & Art Participation Funds**

## What is Sporting Chance and the Arts **Participation Fund?**

Sporting Chance and the Arts Participation Fund are two funds set up by Upper Hutt City Council, which aim to assist young people where financial hardship, as a result of COVID-19, is a barrier to participation in sports and physical activity and/or in art and culture.

## **Application Criteria**

The applicant's immediate family is unable to support them, as a result of COVID-19, in providing the necessary equipment, clothing or other related costs to enable participation in sport or physical activity and/or art and culture.

- 1. The applicant must live in Upper Hutt.
- 2. The completed application is genuinely in aid of assisting participation in sport or physical activity which otherwise would not take place.
- 3. A quote is required for clothing, footwear and equipment.
- 4. A letter from the club/school/class/group with a cost breakdown of fees is required if applying for fees/subs.
- 5. Funding will not be given retrospectively.
- 6. The maximum amount that can be granted for a single applicant is \$500 + GST.

Sporting Chance and the Arts Participation Fund offers assistance for students, ages 5 - 18, who meet the criteria for one or more of the following purposes:

- Sports club or dance/art/music/culture/ theatre... etc . class fees
- Equipment not provided through the sporting club or dance/ • art/music/culture/ theatre...etc classes
- Uniform, footwear or clothing/costumes associated with • sports or dance/art/music/culture/ theatre classes

Generally, the Funds do not cover:

- Equipment which can or should be provided by clubs and • schools for participation in team sports
- Travel to tournaments and competitions
- High performance students who face barriers to success • rather than participation.

## **Conditions of assistance:**

- 1. Equipment/footwear The Fund administrators will purchase the goods from a preferred supplier on the applicant's behalf.
- 2. Club/class/groups subscription/fees Payment will be made directly to the appropriate organisation.

#### How to Apply

Complete the application form attached. Families can apply for more than one child and for more than one activity across both the Funds.


